For AGM 7 April 2021: Proposed Changes to:

Constitution of the Wellington Tramping and Mountaineering Club

1. NAME

a. The name of the Club shall be the "Wellington Tramping and Mountaineering Club Incorporated".

2. INTERPRETATION

- a. It is assumed that:
 - i. Where a masculine is used, the feminine is included, and vice versa-
 - ii. Where the singular is used, plural forms of the noun are also inferred
 - iii. Headings are a matter of reference and not part of the rules
- b. "Notice" means communication by post, electronic means (including email, and website posting), or advertisement in periodicals, or a combination of these methods.
- c. "Club" shall mean "Wellington Tramping and Mountaineering Club Incorporated".
- d. "Committee" unless qualified to give a different meaning shall mean "General Committee" as defined in Section 15.
- e. "Member" unless qualified to give a different meaning, shall mean "member of the Club".

3. OBJECTS

- To encourage and facilitate <u>outdoors activities including tramping</u>, <u>mountaineering</u>, walking, climbing, <u>mountaineering</u>, and <u>kayaking</u>, skiing, and other related <u>outdoor activities</u>, but always subject to (c) and (d).
- b. To encourage and facilitate such field interest as accord with object (a), such as botany, and photography, eteamongst others, but always subject to (c) and (d).
- c. -To preserve and protect the native <u>flora and</u> fauna, except for such shooting of native game as may be permitted by the Government from time to time, such shooting to be subject to the rules of the club.
- d. To endeavour to achieve, maintain and to co-operate in the preservation of the Tararua mountain and forest areas as a natural, unspoiled reserve and to

- oppose further substantial development which appears to violate this object.in the Greater Wellington region.
- e. To encourage and facilitate social <u>intercourseinteractions and to foster community</u> between members.
- f. To build and maintain huts and resorts lodges and to cut tracks; and to cooperate cooperate with other clubs and to invest funds, and to do other such
 acts as may reasonably accord with the above by objects, but always subject
 to (c) and (d).
- g. To promote and facilitate environmentally responsible and sustainable behaviour and action across all club activities, and otherwise in terms of sustaining, preserving and protecting mountain, forest and other natural areas for current and future generations.

4. COLOURS AND BADGE

a. The Club colours shall be light blue, dark blue and gold, with the light blue to predominate.

5. BADGE

a. The Cluband badge shall be as illustrated agreed to by a simple majority agreed by of eligible members at a General Meeting.

5. 6-MEMBERSHIP

- a. The club shall comprise Adult, Household, Veteran, Veteran Household, Junior, Friends of the Club and Life members.
- a. The club shall include memberships for adults and minors; friends of the club as described in (6.h); life memberships as described in (7.a); and other membership types as agreed to by two thirds of the Committee.
- b. All persons declared to be members at a general meeting, Thursday, 11th 11 December 1947, shall be deemed to be elected members of the Club.
- c. Persons interested in the objects of the Club shall be eligible for membership as the General Committee may determine, and may be elected by a two-thirds majority of those present and voting at a meeting of the Committee: provided that the Committee may require such tests of tramping or mountaineering, climbing or other relevant outdoor interest as it may think fit; and provided that with respect to such applications the applicants meet such conditions as the Committee may from time to time determine.
- b. Members under the age of 18 years shall not be eligible to vote at General Meetings, nor to nominationnominate for positions on the club's Committee, but shall in all other respects have full members' rights.
- d. Persons under the age of 18 shall only be eligible for junior membership, or can join as part of a household membership.

- e. Members may change from one type of membership to another by fulfilling such conditions as the Committee may from time to time determine.
- f. Membership shall be subject to the clauses relating to payment of subscriptions and may be qualified by the provision of Section 9.
- g. Notice shall be given or sent within 30 days advising each new member of his election.
- h.—Persons who are 'Friends of the Club' shall receive Club <u>publications and</u> <u>correspondence sent to all other members from the Club Newsletters</u>, <u>Journals</u>, and other <u>publications and correspondence from the Club as the General Committee will determine from time to time</u>; but they are not elected members and shall not receive any other rights or benefits of members.
- h. Membership is and remains contingent on members abiding by any club policies and any other governance and related documents agreed to at an Annual General Meeting or Extraordinary General Meeting.

6. LIFE MEMBERSHIP

a. a. On a motion of which previous notice has been given to the Committee or on the Committee's recommendation, any person who has rendered special service to the Club or to the furtherance of its objects may be elected to life membership by two thirds of those present and voting at a general meeting of the Club. Life membership shall have full privileges, but shall be exempt from payment of the subscription.

7. **S. SUBSCRIPTION**

- a. The subscription shall be <u>annual</u>, <u>with the amount each year</u> as <u>mayto</u> be determined by <u>athe</u> <u>General</u> Committee <u>from time to time</u>.
- b. The due date for payment of the subscription shall be the date upon which the notice is sent advising him of his election (in the case of a new member). The date in other cases shall be the first day of the financial year.
- c. The Committee may at its discretion require advance payment of subscriptions with applications for membership, subject to such later refund or rebate as may be necessary due to delay or failure to elect.
- d. The Committee may, at its discretion, remit all or part of the subscription in the case of hardship, or in the case of outstanding service to the club, or in the case of absence from New Zealand for a period of more than six months.

 Members whose subscriptions are remitted for any of these reasons shall be deemed to be financial members, provided that such remission has effect only for the year in which it is made.
- e. The Committee may, at its discretion, grant a discount in respect of subscriptions that are paid before the first day of the financial year (i.e paid by 1st February)specified due (renewal) date. Where the subscription is paid in full but the discount could have been claimed the Club will not be bound to refund the discount.

8. 9. FINANCIAL AND UNFINANCIAL MEMBERS

- a. New members whose subscriptions are paid and other members, whose subscriptions are not more than threetwo months overdue, shall be deemed to be financial members; except as provided in Section 7 and Section 8(d) all other members shall be deemed unfinancial members.
- a. <u>Unfinancial Members deemed to be nonfinancial</u> members may not vote at a General Meeting, except bywhere a Life member, or where the consent of the majority of the financial members present.
- b. The Committee may, at its discretion, exerciseagrees to a deferment or waiver of payment for that year, shall cease to be recognised as members or have any of the following powers in respect to unfinancial members; it may exclude such members from acting on the committee or any sub-committee; it may withhold notices of publications; it may require financial members to be given preference on trips; it may terminate the membership of unfinancial members rights or claims until they become a financial member.

9. 10. RESIGNATION

a. Any member may resign his membership by giving notice to the Membership Officer in writing to that effect.

10. 41. EXPULSION

a. The Committee may expel any member disobeying the rules of the Club, or seriously disregarding the Constitution, or guilty in its opinion of gross misconduct; provided that before expelling him or her the Committee shall give him an opportunity to appear before it and make such explanation as he may reasonably wish in his own defence.

12. TERMINATION OF MEMBERSHIP IF UNFINANCIAL

a. As provided in Section 9(c) the Committee may terminate the membership of any unfinancial member. It may do so without notice to the member.

11. 13. MANAGEMENT

- a. Subject to anything elsewhere laid down in the Constitution or to any instructions from a -General Meeting, the entire management of the Club, and its property, including the control -and investment of its funds, shall rest in the hands of the General-Committee except that -other committees or sub-committees shall have control in their own particular fields, subject -to instructions from the General-Committee and provided always that the committee in its -actions shall aim to actively encourage the attainment of the Club's objects, ensure the wellbeing of the Club as a whole, and both further and protect the interests of individual -members.
- b. The Committee shall, from time to time appoint three trustees, one of whom shall be -Treasurer, to operate bank accounts and other financial accounts as relevant (for example, fuel cards) on behalf of the Club.

12. 44-RIGHTS OF RESTRICTION

a. The General Committee, or other committees or subcommitteessubcommittees or appointed Officers subject to instructions from the General Committee, may limit the privileges of certain members or classes of members in reasonable ways as in the exclusion of certain trips of those considered unfit, exclusion from clubroom for a period after commencement of a function, hiring out of equipment only to those who need it or will look after it, or to financial members and so on.

13. 15. GENERAL COMMITTEE

- a. The General Committee shall consist of a President, a Vice President, a Chief Guide, an Assistant Chief Guide, a Secretary, a Treasurer, a Social Convenor, a Ruapehu Lodge -Convenor/Maintenance Officer, a Membership Officer, a Transport Officer, and such other-special Officers and/or further Committee members as may be elected at a General Meeting or later appointed by the Committee itself, provided that no person shall hold the office of Treasurer- unless he be qualified to do so, either by examination or experience. One member may hold two or more offices aside from the President, Chief Guide, Secretary and Treasurer.
- b. The number of special Officers and Committee members elected at a General Meeting shall not exceed 15 but Committee shall have the power to add up to three more. c. The Committee may appoint any member to fill any vacancy until the next General Meeting.

14. SUB-COMMITTEES

- a. Sub-committees may be established by the Social Convenor, President or the Chief Guide, or by any other role as agreed to by two thirds of the General Committee; and other sub committees may be established by the General Committee. Any Club member may be appointed to these committees whether members of the General Committee or not.
- b. No appointments by the convenors shall be valid unless approved by the Committee.
- c. The Committee may reform any sub-committee except that if the convenor of such committee is an Officer elected at a General Meeting he will cease to be convenor only by his resignation from the post or as determined by a General meeting.

15. 17. MEETING OF GENERAL COMMITTEE

a. A meeting of the General Committee may be called at any time by the President or Secretary and shall be called within 14 days of the receipt of a requisition signed or sent by email by two members of the Committee. There shall be held not less than nine Committee meetings in each year.

16. 18. ANNUAL GENERAL MEETING

a. The Annual General Meeting shall be held on the same daywhere practical in

- <u>early</u> April, the date to be decided by the Committee. The business shall be the election of Officers and other such business as may properly be put before the meeting.
- b. Nomination for office shall be subject to three weeks notice in writing and shall be with the consent of the nominee. OutgoingOut-going Officers must be re-nominated. All nominations to be posted on the Club website two weeks before the Annual General Meeting. An out-going President unless he declines shall be ex-officio Vice President for the year.
- c. No person shall be nominated unless he has been duly elected a member of the Club.
- d. Other Club business except motions as provided in Section 26 shall be subject to such notice of motion as the Committee may require.

17. 19. EXTRAORDINARY GENERAL MEETING

a. The Committee may at any time convene an Extraordinary General Meeting and shall do so within one calendar month of a request to the Secretary in writing, specifying the proposed business and signed by six financial members.

18. 20. NOTICE OF MEETINGS

a. Notice of any meeting of the Committee shall be given to each member of the Committee at least forty eight hours before handbeforehand. Notice of General Meeting shall be given to all members of the Club at least seven days before handbeforehand.

19. 21. QUORUM

- <u>a.</u> The quorum at a meeting of the <u>General-Committee</u> shall be <u>five</u> <u>a simple</u> <u>majority of the Committee</u>. <u>Committee</u> members. <u>b.</u> <u>are not able to substitute</u> other members for Committee voting purposes or to achieve a quorum.
- <u>a.b.</u> The quorum at a General Meeting shall be <u>fifteen twelve</u> members <u>eligible to</u> <u>vote</u> or five per cent of the membership, <u>whichever is the smaller eligible to</u> <u>vote</u>, <u>whichever is the smaller</u>.

20. 22. METHOD OF VOTING AND PROXIES

- a. The method of voting at General Meeting and Committee meetings shall in all cases be at the discretion of the Chairman, except as otherwise decided by a majority of those present. Chair. b. Except where otherwise laid down in the Constitution any motion shall be deemed to be carried by a bare majority vote.
- a. Members may nominate a proxy to vote on their behalf.

23. CHAIRMAN AND

21. CHAIR AND RULING AGAINST THE CHAIR

- <u>a.</u> The President shall be <u>ChairmanChair</u> at all meetings if he <u>or she</u> is present. In <u>histhe President's</u> absence <u>a, the</u> Vice President shall <u>take his place.</u> <u>be</u> Chair.
- <u>b.</u> Any member may demand a vote which shall thereupon be taken against any ruling of the <u>ChairmanChair</u>. The decision of the meeting shall stand. <u>b.</u>
- a.c. The Chairman Chair shall at all times have an ordinary and a casting vote.

22. 24. FUNDS

- a. The funds and property of and belonging to the Club, may be applied in the manner and for the purposes following, that is to say:
 - i. In payment of all expenses of and incidental to the carrying out of the objects of the Club, or any of them, including in particular, (but without prejudice to the generality of this present clause), rent and upkeep or improvement of buildings and rooms and interest on money lent to the Club on bank overdrafts or otherwise, and salaries, wages or honorarium to the officers of the Club, or persons employed by the Club.
 - ii. In the purchase and improvement of real and personal property, to be used for and in connection with all or any of the objects of the Club.
 - iii. In investment upon any security hereby authorised.
 - iv. In any other manner which may from time to time be authorised by the members of the Club in General Meeting.
 - v. The income and property of the Club shall be applied solely towards the promotion -of the objects set forth above, and no portion thereof shall be paid or transferred, -directly or indirectly, by way of dividend, bonus or otherwise, as profits to members -of the Club.

23. 25. INVESTMENT OF FUNDS

a. The funds of the Club, not immediately required for carrying out the objects of the Club, may -be invested in or upon mortgage or real estate in New Zealand, or upon deposit in any bank, -savings bank, any member of the New Zealand Law Society, or deposit company, carrying on -business in New Zealand, in or upon Government Securities in New Zealand or any security approved by law, for the investment of Trust Funds, or any company or undertaking whose -primary object shall be the development of any facility upon or about Mount Ruapehu, and -who shall be selected and nominated for the purpose by a General Meeting of the Club, but -no investment of any kind shall be made until the same has been approved and confirmed -by the General Committee. The Club may retain as an investment, any fully paid

shares that are given or bequeathed to the Club.

- b. An imprest account may be opened and maintained at call by the Committee, in any branch of any Trading Bank in New Zealand.
- c. The Club shall, in addition to the powers vested in it, have power to borrow or raise money, from time to time, by the issue of debentures, bonds, mortgages or any other security founded or based on all or any of the property and for rights of the Club or without any such security, and upon such terms as to priority and otherwise.

24. 26. ALTERATION OF THE CONSTITUTION

a. The Constitution may be repealed, altered, or added to by resolution at a general meeting. -Any motion or motions to repeal, alter or add to the Constitution shall be given to the Secretary in writing three weeks beforehand and published with notice of meeting.

25. DUTIES OF SECRETARY AND TREASURER

a. The Secretary and Treasurer shall keep such records and books of accounts, including financial records, as may from time to time be required by the Committee.

26. 28. FINANCIAL YEAR

a. The financial year shall begin on the first day in February each year.

27. 29. STATEMENT

a. A Statement of Income and Expenditure and Balance Sheet together with an Annual Report shall be prepared and a copy of these documents shall be forwarded to each member with notice calling the Annual General Meeting.

28. 30. ASSURANCE ON THE FINANCIAL STATEMENTS

- a. The Committee shall appoint an accountant to review the annual financial statements of the Club ("the Reviewer"). The Reviewer shall conduct an examination with the objective of providing a report that nothing has come to the Reviewer's attention to cause the Reviewer to believe that the financial information is not presented in accordance with the Club's accounting policies. The Reviewer must be a suitably qualified person, preferably a member of the New Zealand Institute of Chartered Accountants, and must not be a member of the Committee. If the Committee appoints a Reviewer who is unable to act for some reason, the Committee shall appoint another Reviewer as a replacement.
- b. The Committee is responsible to provide the Reviewer with:
 - i. i-Access to all information of which the Committee is aware that is relevant to the preparation of the financial statements such as records, documentation and other matters;
 - ii. Hadditional information that the reviewer may request form the

Committee for the purpose of the audit; and

iii. Reasonable access to persons within the Club from whom the reviewer determines it necessary to obtain evidence.

29. 31. DUTIES OF MEMBERS AND SOME PROVISION RE ATTENDANCE ON TRIPS

- a. Members must act in accordance with the club values, behaviours, and policies.
- a.<u>b.</u>Dogs andor guns maymust not be taken on Club trips except with the permission of the Chief Guide.
- <u>b.c.</u> Gates must be left as found, unless there is good reason to believe the owner wishes the contrary.
- e.d. Huts All property, including huts and private property, must be respected.
- d.e. Fire must always be left safe and must never be lit where it is likely to spread. Fire must not be lit when or where there are official fire bans in place.
- e.f. Sub-sections (c) and (d) of Section 3 must be observed at all times.
- f.g. Leaders must have complete authority on trips subject only to the Chief Guide or his or her appointed deputy.
- g.h. Except where it is not reasonably possible or where considerable service is already being rendered to the Club, all members shall be expected to do their bit in the way of Club duties, and duties at other Club functions and it shall be competent for the Social Convenor or other nominee of the Social Committee with approval of the General Committee to notify members accordingly.

30. 32. ADDRESS OF MEMBERS

- <u>a.</u> Every member shall, on joining, supply the Membership Officer with his <u>email and/or physical</u> address and shall give notice of later changes of address. any addresses given.
- a.<u>b.</u>All notices sent to the latest address obtained from members shall be considered duly sent.

31. 33. DISCLAIMER OF LIABILITY

a. The Club shall not be responsible for acts of its members which may lead to death, disablement, or injury and/or damage to or loss of property either of members or others.

32. 34. DISPOSAL OF PROPERTY ON WINDING UP

a. Upon the winding up of the Club, its property and funds shall be disposed of as decided by a -General Meeting of members, which shall be convened (if not otherwise held) for the- purpose, or failing any such resolution, the Committee may act in the matter.

33. 35. COMMON SEAL

- a. The Common Seal of the Club shall be affixed to any document only by special resolution of the General-Committee and shall be attested by the President and one other Committee member.
- b. The Secretary shall have custody of the Common Seal.
